This means that people may have the right to a pension with Coats and not even know it! We have attempted to provide a comprehensive list of the companies which Coats has purchased over the years. Most importantly, you would need to have paid into a pension plan to be entitled to any benefit – simply working for a company listed here would not be enough! Anyone who left employment before 1975 with one of these Companies would have received a refund of their contributions.
